

## END USER LICENSE AGREEMENT (EULA) FOR THE "Spatial Touch™" APPLICATION

IMPORTANT: PLEASE READ CAREFULLY BEFORE USING THIS APPLICATION.

- 2.4. Distribute, sublicense, lease, rent, or lend the "Spatial Touch™" Application to any third party.
- 2.5. Use the "Spatial Touch™" Application in a manner that violates any applicable law, regulation, or third-party right.
